

On September 21, 2017, an Order Commencing Liquidation Proceedings & Granting an Injunction & Automatic Stay of Proceedings was issued by the undersigned as Chief Administrative Judge for the Fifth Judicial Circuit in the Court of Common Pleas for the State of South Carolina and filed September 27, 2017.

It has been brought to the attention of the Court that there is some confusion among the Bench and Bar in other jurisdictions as to whether the injunction and automatic stay set forth in the Order which is "applicable to all persons and proceedings" and which prohibits, among other things, "the institution of further prosecution of any actions or proceedings" includes prohibiting actions against the policyholders of Oceanus which would be the insured physicians which are also referred to as covered providers and additional named insureds of Oceanus Insurance Company.

So as to clarify my Order of September 21, 2017, this Order is to confirm that the automatic stay prohibiting "the institution of further prosecutions of any actions or proceedings" includes prohibiting actions or proceedings against the policyholders, covered providers and additional named insureds of Oceanus Insurance Company.
